



Department for International Development – Nepal Health Sector Support Programme (DFID-NHSSP) Request for Expression of Interest (EoI)

DFID - NHSSP is a technical assistance programme to the Ministry of Health and Population (MoHP), funded by the UK Government through the Department for International Development (DFID). NHSSP is a technical component of DFID's support to the MoHP under the Nepal Health Sector Programme-3. It is designed to support the goals of Nepal Health Sector Strategy (2015/16-2020/21) and contribute to the MoHP's efforts to provide quality health services leaving no-one behind.

From April 2017 to December 2020, the programme is being implemented by a consortium led by Options Consultancy Limited, with HERD International, Oxford Policy Management, and Miyamoto International. The programme has two components.

- **A. General Health Technical Assistance (GHTA)** to increase the capacity of the MOHP to improve health policy-making and planning, procurement and financial management, health services and the use of evidence for planning and management.
- **B. Retrofitting Health Infrastructure Technical Assistant (RHITA)** increase the MOHP's capacity to retrofit health infrastructure to withstand future earthquakes.

Both components are integrated and provided by a team based in Kathmandu and "embedded" with the Government of Nepal.

The DFID-NHSSP comprises streams of work delivered through an overarching, integrated, capacity enhancement approach. These five streams of work are:

- 1. Health Policy and Planning (HPP)
- 2. Procurement and Public Financial Management (PPFM)
- 3. Service Delivery (SD)
- 4. Evidence and Accountability (EA)
- 5. Retrofitting Health Infrastructure Technical Assistant (RHITA)- Health Infrastructure (HI)

- List of clienteles served during last 3 years with performance certificate
- Other services / facilities like contact of person during off hours or holidays in case of emergencies, discounts, international hotel bookings, terms of payment etc.
- Membership certificate of NATA, NATO and IATA Certificate in addition to documents mentioned above.

6. Layout Design and Print of Reports / Visibility Materials

Companies that can provide layout designing & printing services, are invited to send an EOI describing about company (not exceeding one page), scope of work and list of clientele. EOI can include basic costing for Printing of A4 size material in specifications as below:-

- **Paper Type**: Art Board for cover page of 190 to 300 gsm in matt/glossy and lamination, in single and multi color
