#### PROCUREMENT OF GOODS AND HEALTH SECTOR GOODS

#### THE STORY SO FAR

For a number of years, there have been comments that the procurement of Health Service Goods by the Logistics Management Division (LMD) of the Department of Health Services, Ministry of Health and Population has been opaque. In order to reduce these notions, DFID have provided two international procurement consultants under NHSSP to assist and to advise LMD.

#### **IMPROVED EFFICIENCY**

With the signing of the Financing Agreement of 18th August, 2010 between the Government and the World Bank, the Government handed over responsibility for procurement of International Competitive Bidding processes to the World Bank's Guidelines for procurement. For National Competitive Bidding processes, the Government retains the responsibility for procurement to be conducted under the Public Procurement Act and Regulations using documents authorised by the Public Procurement Monitoring Office. These procedures have been improved giving rise to increased efficiency. Standard Bidding Documents, and bidding procedures have been enhanced, bid openings have been streamlined, bid evaluations have been tightened and contracts have been awarded on a more equitable basis.



### TRANSPARENCY

Transparency has been improved with the publication of all important documents, which are now uploaded onto LMD's website (www.dohslmd.gov.np) and are available for inspection by all.

## THE CONSOLIDATED ANNUAL PROCUREMENT PLAN

All procurement by LMD is subject to being included in a Consolidated Annual Procurement Plan (CAPP). This is produced by gathering together all the Divisions from within the DoHS and receiving their 'orders' for Goods and Services for the following year. This process begins very early in the calendar year to ensure that it is prepared by the end of the GoN Financial Year. In the past this was not always possible. Having gathered the Divisions' wishes, these are consolidated with identical items amalgamated to increase the 'buy' and to take advantage of economies of scale. An additional benefit of this approach is to encourage international bidders to participate thus increasing the competition. The resulting document is subject to approval by the World Bank, which acts as a further filter for the accuracy and transparency of the procurements. Furthermore, multi-year contracts have been included to increase the amounts purchased and give rise to cheaper unit prices.
